To: Driver Education Students and Parents/Guardians

The Purpose of this letter is to notify you that Clearbrook-Gonvick Community Education will offer the classroom phase of Driver Education beginning on <u>August 7th</u>, <u>2023</u>. The following calendar shows the tentative schedule.

<u>Parent meeting will be Thursday, August 17th at 6:30 pm.</u> Parent attendance is recommended. Upon completion, parents will receive a certificate of completion which means their student driver only needs to log 40 hours of practice driving on their driving log. If a parent does not attend a parent class their student must show 50 hours on the driving log. This is a perfect way to get all of your questions answered about new laws and procedures for helping your child attain a driver's license.

Classes will begin at 5:00 pm at the High School (Mr. Kroulik's room). All classes run from 5:00-7:30 pm. <u>Parents should be</u> at the school promptly at 7:30 pm to pick up their child!

We are excited to have found a new instructor teaching our Driver Education class. His name is Russ Bly from Fosston and he has been teaching Driver Education for many years.

<u>Please be aware that attendance is critical!</u> The Department of Public Safety requires 30 hours of classroom instruction.

This is a requirement set by the State of Minnesota (not the instructor). If a conflict arises that cannot be avoided, you must attend the make-up class. There will be one make-up day decided at a later date.

The cost of Driver Education is \$300.00. You may choose to pay the fee all at once or in two payments: \$125 deposit prior to the first classroom session and the \$175 balance is due at the start of Behind-the-Wheel instruction. Paperwork and payments can be dropped off in the school office at any time throughout the summer.

\*\*\* Remember: a \$125 deposit or full amount must be paid before or by the first classroom session along with paperwork!

**Behavior:** Driving is a privilege, not a right. Getting a license to drive requires maturity and responsibility. Proper behavior is required at all times during classroom sessions. Improper behavior will not be tolerated. If a student is asked to leave due to improper behavior, it will be counted as an absence and the student must attend the make-up class. If a student is asked to leave a second time, he/she will be dropped from the class.
